For the record, I assumed that you weren't working for the State Department anymore and I didn't want the journalists, and/or other people, to think that I made a mistake by sending the email to the wrong address so that's why you can see, if you open this last link I just gave you, that I didn't redact your email address. If you want, I can update the website and redact it. Please let me know or I will assume that it doesn't matter. But I think it's kind of disturbing that email addresses can be turn on and off just like this especially considering it might have legal implications if I try to submit you evidence and nobody is on the other end receiving what I am sending. How am I supposed to formally notify the FBI if I want to send you additional information and/or evidence and/or explanations?

MR. ROGALSKI, PLEASE, LET'S GET BACK TO WORK QUICKLY: IT'S A MAJOR, UNPRECEDENTED, RICO CASE!

I've fighting for justice for more than 10 years. I first contacted the FBI and the SEC in 2015. Back then, I still hadn't been formally fully advised by an attorney yet. I learned lots of things since then.

A few questions for you Mr. Rogalski:

- 1. Have you received and read the 2-page Statement of Facts that Mr. Edward Lehman, who is in copy of this email, asked me to write?
- 2. If you received and read the 2-page Statement of Facts, did you understand everything I tried to explain? Do you have any questions?
- 3. Did you read the explanations I sent to New York Times journalist Constant Méheut? I am talking about this one: <u>https://www.tojournalists.com/open-letters/explanations-sent-to-constant-meheut-may-25-2022/</u>
- 4. Do you understand the explanations I sent to New York Times journalist Constant Méheut? Do you have any questions. (Quickly, this fraud I explained to Constant Méheut also took place in other countries including the United States)
- 5. Who is the Special Agent in Charge of the criminal investigation?
- 6. Page number 52 of the Attorney General Guidelines for Victim and Witness Assistance, 2022 Edition states that "During the investigation of a crime, unless prohibited by a specific statute, regulation, or Department policy, a responsible official for the investigative agency shall use their best efforts to provide persons meeting the VRRA victim definition (see Art. III.B (VRRA Definition)) with the earliest possible notice concerning: a. The status of the investigation of the crime, to the extent that it is appropriate and feasible to inform the victim and to the extent that it will not interfere with the investigation." Mr. Rogalski, what's the status of the investigation of the crime? I first contacted the FBI in 2015, it's not been 7 years and the pattern of racketeering activity is ongoing.
